ORDER

Sub: DRDM – Explosives – Illegal manufacture and storage – explosion – Regarding

Kind attention is invited to the recent instance of explosion in a house in disuse, at Mudaliarpet on 16.09.2016.

2. Manufacturing and storing explosives without proper valid licence is violation of provisions of Explosives Act 1884, and rules made thereunder. The undersigned therefore, directs that a report in Excel sheet format on the following shall be submitted immediately

- a) Number of authorised explosive manufacturing units
- b) Location of authorised explosive manufacturing units
- c) Name and address of persons authorized to manufacture explosive with valid licence in their jurisdiction
- d) Name and address of persons authorized to store and sell explosive with valid licence in their jurisdiction
- e) Quantity of explosives permitted for manufacture / storage
- f) Persons involved in making country bombs
- g) Specific remarks if any

3. The Superintendent of Police (L&O) shall submit Police Station wise report, the Sub-Divisional Magistrates shall submit village wise report and the Commissioners of local bodies shall submit ward wise / commune wise report.

4. The SDMs may seek the assistance of police personnel for conducting inspection/ search of the explosive manufacturing / stocking premises or any place suspected to be used for such activities.
