The Bureau of Civil Aviation Security (BCAS) is an attached office of the Ministry of Civil Aviation. BCAS is responsible for laying down the standards for pre-embarkation security and anti-sabotage measures in respect of civil flights and ensuring their compliance through regular inspections and Security Audits. The aim of BCAS is to safeguard civil aviation operations against acts of unlawful interference. Recently, as part of restructuring process approved by the Government, the staff strength of BCAS has been increased from 191 to 590 and number of Regional Offices increased from 8 to 20.

2. The Bureau has invited applications from suitable candidates for filling up the posts of (i) Aviation Security Assistant (equivalent to Constable) (ii) Staff Car Driver (iii) Dispatch Rider in the Level 2 in the pay matrix on deputation basis. (copies of vacancies circular attached).

3. All above posts are base posts in this Bureau and essential for smooth functioning of the organization. These are required to be filled expeditiously in interest of aviation security as well as in larger public interest.
