ORDER:

The following Notification shall be published in the next issue of the extraordinary official Gazette:-

NOTIFICATION

WHEREAS orders were issued in pursuance of sub-section (3) of section 3 of the National Security Act, 1980 (Central Act 65 of 1980), directing that the District Magistrate, Puducherry and Karaikal may also, if satisfied as provided in sub-section (2) of the said section, exercise the powers conferred by the said sub-section for a period of three months from 28th October, 1981 in the Home Department's Notification issued in G.O.Ms.No.61, dated 28th October, 1981;

2. AND WHEREAS the said period has been extended from time to time in exercise of the powers conferred by the proviso to sub-section (3) of section 3 of the said Act and the last extension thus given for a period of three months totally three hundred and thirty three months upto and inclusive of 27th July, 2009 in the Notification issued in the Home Department's G.O.Ms.No.23, dated 27th April, 2009;

3. AND WHEREAS the Lieutenant-Governor, Puducherry having regard to the circumstances prevailing in the Union Territory of Puducherry is satisfied that it is necessary to extend the said period by three months beyond 28th July, 2009;

4. NOW, THEREFORE, in exercise of the powers conferred by the proviso to sub-section (3) of section 3 of the National Security Act, 1980 (Central Act 65 of 1980), the Lieutenant Governor, Puducherry hereby makes the following amendment to the Home Department's Notification issued in G.O.Ms.No.61, dated the 28th October, 1981, namely:-

AMENDMENT

In the said notification as amended last by G.O.Ms.No.23 dated 27th April, 2009 of the Home Department, for the words, "three hundred and thirty three months" the words "three hundred and thirty six months" shall be substituted.

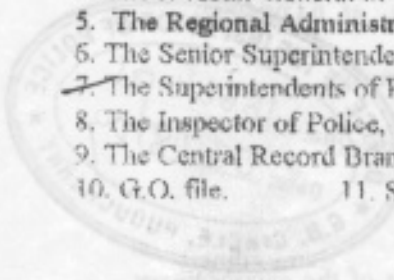
