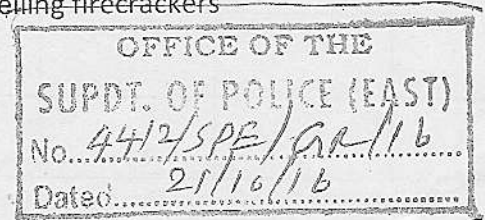

CIRCULAR

Sub: DM – Deepwali 2016– Regulation of sale and use of Fireworks –
Constitution of Taluk level teams – Reg

As per the directions of the District Magistrate, Puducherry, the Sub-Divisional Magistrates shall constitute teams to ensure that all the shops selling firecrackers

- a) have valid licences
- b) are not selling fire crackers of foreign origin
- c) are in conformity with legal and safety aspects



2. The team shall be constituted at the level of Station House Officer and the team shall comprise of the following members;

- (i) Deputy Tahsildar-cum-Executive Magistrate
- (ii) Station House Officer
- (iii) Revenue Inspector of the concerned Firka and
- (iv) Village Administrative Officer of the concerned Revenue Village

Forwarded for Necessary action
Mut. PS / Kai. PS / O.P.

3. The Station House Officers shall:

- (i) Liaise with the concerned Executive Magistrates
- (ii) Provide necessary security arrangements for the Executive Magistrates
- (iii) Accompany the Executive Magistrates during visit to the crackers sale locations.

4. The constituted team shall inspect the premises of explosives manufacturing units and shops selling firecrackers. They shall also conduct surprise inspection/raids in these locations and furnish weekly report in the enclosed annexure format to the concerned SDM and District Magistrate.

5. The Tahsildars and Circle Inspectors shall also be on routine monitoring of the sale of the fire crackers.
