**ORDER:**  
The following Notification shall be published in the next issue of the extraordinary official Gazette dated 25.01.2011:-

**NOTIFICATION**

WHEREAS orders were issued in pursuance of sub-section (3) of section 3 of the National Security Act, 1980 (Central Act 65 of 1980), directing that the District Magistrate, Puducherry and Karaikal may also, if satisfied as provided in sub-section (2) of the said section, exercise the powers conferred by the said sub-section for a period of three months from 28<sup>th</sup> October, 1981 in the Home Department's Notification issued in G.O.Ms.No.61, dated 28<sup>th</sup> October, 1981;

2. AND WHEREAS the said period has been extended from time to time in exercise of the powers conferred by the proviso to sub-section (3) of section 3 of the said Act and the last extension thus given for a period of three months totally three hundred and fifty four months upto and inclusive of 27<sup>th</sup> January, 2010 in the Notification issued in the Home Department's G.O.Ms.No.53, dated 27<sup>th</sup> January, 2010;

3. AND WHEREAS the Lieutenant-Governor, Puducherry having regard to the circumstances prevailing in the Union Territory of Puducherry is satisfied that it is necessary to extend the said period by three months beyond 28<sup>th</sup> January, 2010;

4. NOW, THEREFORE, in exercise of the powers conferred by the proviso to sub-section (3) of section 3 of the National Security Act, 1980 (Central Act 65 of 1980), the Lieutenant Governor, Puducherry hereby makes the following amendment to the Home Department's Notification issued in G.O.Ms.No.61, dated the 28<sup>th</sup> October, 1981, namely:-

**AMENDMENT**

In the said notification as amended last by G.O.Ms.No.53 dated 27<sup>th</sup> October, 2010 of the Home Department, for the words, "three hundred and fifty one months" the words "three hundred and fifty four months" shall be substituted.
