Sub.: Conduct of General Election to the Puducherry Legislative Assembly 2016 - Model Code of Conduct - Constitution of Standing Committees - Order - Issued. ooOoo

The Election Commission of India will be announcing the schedule for the conduct of the General Election to the Puducherry Legislative Assembly, 2016 very shortly. With the announcement of the Election, the Model Code of Conduct will come into force. In order to ensure total compliance with the Model Code of Conduct and also for considering specific violations of the Code, District wise and Constituency-wise Standing Committees comprising of the following members is constituted with immediate effect:

Returning Officer of the Assembly Constituency concerned	Chairman
Inspector of Police of the Assembly Constituency concerned	Member
Contesting Candidate(s)	Member
AROs of the Assembly Constituency concerned	Convener
