SENSATIONAL MURDER CASE OF VILLIANUR PS SOLVED

With the arrest of six accused persons, the sensational murder case of Villianur Police Station has been solved.

On 14.07.2018, a case of 'Murder' was registered at Villianur Police Station on the complaint of Shri. Innarasan, r/o Karayanpet, Villianur, Puducherry that in the evening hours of 14.07.2018, when he alongwith his friend Thamizh @ Ilavarasan were riding on a bike at Kanuvapet, Villianur, a gang led by one Iyyanar of Kanuvapet, waylaid them and killed his friend Thamizh @ Ilavarasan with long knives. The investigation of the case was taken up in the right earnest under the leadership of SP(West) K. Gunasekaran, who led the team, comprising of Circle Inspector Arumugam, Inspector/STF Karthikeyan, SI/STF Ramesh, SI/STF Santhosh, SI Velayan and Men of Villianur Circle and STF.

The Police team deployed sources in the area and extensively examined the witnesses and locals. The tactful and sincere efforts revealed the real motive for the murder and finally, the Police team located the accused persons, who were on the run across Puducherry and Tamilnadu areas. On 16.07.18, the Police team laid separate traps and the accused persons, viz., (1) **Iyyanar @ Thadi Iyyanar** (24 years) S/o Sekar, (2) **Manikandan @ Katta Mani** (23 years) S/o Perumal, (3) **Chandru @ Ajithkumar** (22 years) S/o Murugan - all residents of Pudhu Nagar, Kanuvapet, Villianur and **3 Juveniles in conflict with law** have been arrested. They have confessed to their crime.

The confession revealed that there is a long standing enmity between the deceased Thamizh @ Ilavarasan and the accused Iyyanar @ ThadiIyyanar. On 14.01.17, there was a quarrel between the deceased and the accused persons, in which the deceased Thamizh @ Ilavarasan had assaulted both the accused Iyyanar @ Thadi Iyyanar & his friend and also made them to kneel down, which infuriated him to kill Thamizh @ Ilavarasan. So, the accused Iyyanar @ Thadi Iyyanar had planned with his associates including one Arjun of Kanuvapet to kill Thamizh @ Ilavarasan and accordingly, they have executed the murder. One Pandian @ Arun Pandian is found to have supplied the weapons to the accused persons; besides, harboured them after the murder. The absconding accused persons Arjun and Pandian @ Arun Pandian will also be arrested soon.

The confession led to the recovery of knives, motor-cycle, mobile phone and blood-stained clothes.

The accused Iyyanar @ ThadiIyyanar is involved in two hurt cases of Villianur Police Station.
