It is to inform that the next DsGP/IsGP Conference is likely to held in October, 2018. Action taken report on implementation of recommendations of the previous conferences is required to be submitted to MHA for further course of action.


2. Internal Security – I Division, MHA has forwarded Recommendation No. 14 *"The Suggestions complied by IB after a comprehensive study of all websites regarding maintenance and improvement of respective websites for the State Police and CAPFs must be implemented within a fixed time frame of three months. This implementation needs to be monitored and re-evaluated before another report is submitted within that time frame."* to BPR&D for its implementation.

It is to further inform that as per the recommendation of DsGP/IsGP Conference, 2016 regarding *"Comparative analysis of various Police Websites for assessing their impact,"* IB has conducted a comparative analysis of all the Police Websites through National Institute of Electronics & Information Technology (NIELIT) and circulated the report to the concerned States/UTs/CAPFs during the DsGP/IsGP Conference, 2017, for implementation of the suggestions made in the report.

4. In view of above, it is requested that status of implementation of suggestions made in the report may be forwarded by 20th September, 2018 for onwards submission of reply to PMO through MHA.
