Sub : Police - Estt. I(A) - Grant of financial upgradation under the MACP Scheme - Orders - Issued.

On the recommendation of the PEB held on 17.01.2018, the Police Personnel listed out in the Annexure are granted financial upgradation under the MACP Scheme, in the next higher pay, as indicated under column 7 in the annexure against the individual concerned.

2. The grant of financial upgradation under MACP Scheme shall be governed by the following terms :-

- a) they are entitled to exercise option to get their pay fixed in the next higher Pay Band/Pay Level in the Pay Matrix based on the date of increment in the present pay, as per rules in force.
- b) no stepping up of pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under the MACP Scheme.
- c) there will not be any further fixation on functional promotion following the financial up-gradation.
