ORDER

Sub: Creation of 'District Missing Persons Unit' – Orders

Ref: Standing Order No. 01/2013 of O/o IGP, Puducherry.

In pursuance of the Standing Order No. 01/2013, issued by the Inspector General of Police, Puducherry regarding guidelines to the IOs, who deals with cases on Missing Persons and Un-identified Dead Bodies, it is imperative to form a 'District Missing Persons Unit (DMPU)' in Puducherry District. Accordingly, the 'District Missing Persons Unit (DMPU)' of Puducherry District is created with immediate effect and Inspector, STF(North) will be the incharge for DMPU in respect of Puducherry District. The duties and responsibilities of the DMPU are as follows :

- i. The SHOs, in whose jurisdiction, a case of Missing Person or Un-identified Dead Body has been reported, has to report to the Inspector – incharge of the DMPU and share the data immediately.
- ii. They should take all possible efforts as prescribed in the Standing Order No.01/2013 in tracing such persons.
- iii. The Inspector – incharge of the DMPU shall furnish the input data immediately to the Inspector of Missing Persons Squad, functioning in CBCID PS, Puducherry.
- iv. The Inspector incharge of the DMPU shall liaise with the Inspector of Missing Persons Squad and compare with the nation-wide inputs.
- v. The DMPU shall use the broad-band connection existing in the Office of STF(North) and shall use the existing staff for uploading the information of Missing Persons and Un-identified Dead Bodies.

- vi. The Inspector - incharge of the DMPU shall ensure the training of his sub-ordinates on data Input and processing methods being offered by the Social Welfare Department, Puducherry.
- vii. The Inspector - Incharge of the DMPU shall prepare a fortnightly report and send to the Inspector - incharge of the Missing Persons Squad.
- viii. The DMPU will be under the direct supervision of SSP(L&O).
