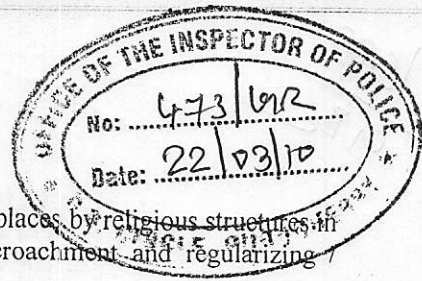

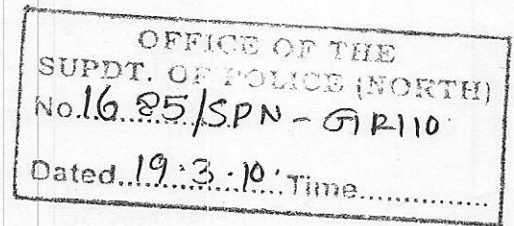
The following notification shall be published in the official gazette:-

NOTIFICATION

Approval of the Lieutenant Governor of Puducherry is hereby accorded for constitution of District Committee in the Union Territory of Puducherry with the following composition to deal with the encroachment and regularizing / removal of religious nature prior to 29.09.2009 :-

PUDUCHERRY DISTRICT

- 1 District Collector
- 2 Senior Superintendent of Police(Law and Order)
- 3 Chief Engineer, Public Works Department
- 4 Director(Local Administration Department)
- 5 Chief Town Planner, Town and Country Planning



KARAIKAL DISTRICT

- 1 District Collector
- 2 Senior Superintendent of Police
- 3 Superintending Engineer, Public Works Department
- 4 Commissioner, Karaikal Municipality
- 5 Junior Town Planner, Town and Country Planning

2. The committee shall meet as and when necessary to conduct detailed of survey regarding encroachments of religious nature and ways of regularizing / removal as per the policy contemplated in G.O.Ms.No.5 dated 18.02.2010 of Home Department, Puducherry as detailed below:-

(i) Religious structures existing on public land without causing obstruction to public movement and over a long period of time shall be considered for regularization on a case to case basis.

(ii) Religious structures existing on public land for a long period of time but which obstruct public movement may be shifted to alternative locations with Cabinet/ Lieutenant Governor's approval.

(iii) All cases of constructions of religious nature on public lands which have taken place after 29.09.2009 should be removed forthwith under intimation to Home Minister / Chief Minister / Lieutenant-Governor. This includes constructions of temporary nature also.

(iv) No further encroachments to be allowed on public land under any circumstances. The land owning agencies and Revenue and Police Departments will be responsible for securing the land.

(v) Public to be duly informed through the media regarding the orders of the Supreme Court of India on the above subject.
