SENSATIONAL MURDER CASE OF D'NAGAR PS SOLVED

With the arrest of the accused persons, the sensational murder case of D'Nagar Police Station has been worked out.

On 15.02.2017, a case of 'murder' was registered at D'Nagar Police Station on the complaint of one Dhanalakshmi, w/o Puviyarasan r/o Lawspet to the effect that her son Murali was hacked to death on 15.02.2017 by a gang of five known accused persons and some others, led by one Sundar of Maduvupet. After committing the murder within the precincts of AKR Lakshmi Mahal, Vazhudavoor road, the dead body was taken by duo in the motor cycle and thrown near Kokkupark junction. The investigation of the case was taken up in the right earnest under the leadership of SP(East) Venkatasamy, who led the team, comprising of Inspector Senthilkumar, SI Kalaiarasan, SI Prathaban, SI Vadivazhagan and PCs Raji, Ambethkar, Raju, Jayakumar, Raja, Hari Prasad, & Mohan of D'Nagar Police Station.

The Police team deployed sources in the area and extensively examined the witnesses and locals. The tactful and sincere efforts revealed the real motive for the attack and finally, the Police team located the accused persons, who were on the run across Tamilnadu areas. On 17.02.17, the Police team laid separate traps and six accused persons, viz., 1. **Sundar @ Sakthivel @ Maduvupet Sundar**, r/o Maduvupet, 2. **Amaran @ Amarnath**, r/o Jeeva Nagar, 3. **Suriya @ Iyyappan**, r/o Vanarapet, 4. **Sarath @ Sarathkumar**, r/o Lawspet, 5. **Mozhi @ Mani @ Manimozhian**, r/o Saram and 6. **Prakash @ Murugan**, r/o Manjakuppam, Villupuram Dt., have been arrested. All of them have confessed to their crime.

Both the deceased person Murali and Maduvupet Sundar came out of jail during the year 2014 after their release in the murder case of one Jegan. Though both of them were close friends, an enmity arose between them recently, owing to some misunderstanding. Besides, Murali's stock was rising in the criminal work, which infuriated Maduvupet Sundar as many of associates of the latter had joined hands with the deceased. He, therefore, hatched a plot with his associates to kill Murali. On the day of incident, one Sendhil Counder of Thattanchavady called the deceased person to come over to his house on the pretext of helping him to reach a compromise with Sundar of Maduvupet. When the unarmed Murali reached there, a gang of accused persons, led by Maduvupet Sundar, who were waiting for the arrival of the deceased person, attacked him with sharp edged weapon on his head, which led to the instant death of Murali.

The accused persons Maduvupet Sundar, Suriya @ Iyyappan, Sarath @ Sarathkumar and Amaran @ Amarnath have previous criminal involvements in cases of murder, hurt & using explosive substances.

Sincere and untiring efforts are continued to nab the absconding accused persons.
