CRUDE BOMBS DETECTED : TARGET OF MURDER PLOT FOILED

With the arrest of two accused persons, a plot to commit murder was foiled.

On 08.04.18, a case of 'attempt to murder' was reported at Thirubuvanai Police Station on the complaint of one Shri. Kalaivendhan, Canteen Manager of 'S' Wines, r/o Kalitheerthalkuppam, Puducherry, where he was attempted on his life by hurling crude bombs at him when he was in the Wine Shop by two known persons. The crude bombs exploded on the wall of the Canteen and caused damages to the show-case of the Wine Shop. The investigation of the case was taken up in the right earnest under the leadership of SP(West) K. Gunasegaran who formed a Team, comprising of Circle Inspector Kalaiselvan, SI Nandakumar, WSI Priya, SI Murugan, SI Pradaban and Men of Nettapakkam Circle.

The team examined the witnesses & locals and ascertained the accused persons as well as the real motive of the offence. Due to sincere and untiring efforts, the team located the accused persons and laid separate traps and on 09.04.18, the accused persons, viz., (1) **Deena @ Dhinagaraj** (26) s/o Rajaraman, r/o No.70, Villupuram Main Road, Koliyanur, Tamil Nadu and (2) **Sugu @ Sugumar** (23) s/o Sekar, r/o Mariamman Koil Street, Metta Colony, Lingareddipalayam, Villupuram Dt.( Tamil Nadu, have been arrested. The duo confessed to the crime.

The thorough and tactful interrogation revealed that the accused persons Deena and Sugu went to 'S' Wines at K. Andiyarpalayam, Thirubuvanai on 08.04.18 at 10.30 AM and consumed liquor along with Omlette. The duo being notorious criminals in the neighbouring District of Villupuram could not establish their supremacy in the Wine Shop, as the Suppliers & Manager of the Canteen could not identify them. This led to an altercation between them and the accused persons about the taste of the Omlette. In order to prove their supremacy, the duo prepared 4 crude bombs and came to the 'S' Wine Shop, K. Andiyarpalayam on the same day evening and hurled at the Canteen with an intention to kill the Suppliers & Manager of the Canteen. However, three crude bombs exploded on the wall of the Canteen and caused damages to the show-case of the Wine Shop. Nobody got injured in the incident. Defusing the non- exploded crude bomb by the Bomb Detection Squad is under process.

The accused Deena is involved in 16 criminal cases including 6 cases of 'Murder', 2 cases of 'Attempt to Murder', 1 case of 'Dacoity', 1 case under 'Explosive Substances Act' and cases of 'Hurt'. The accused Sugu is a bootlegger of Tamilnadu and involved in many cases of 'Hurt'.
