SENSATIONAL MURDER CRACKED WITHIN 12 HOURS

With the arrest of 10 accused persons including a Juvenile Delinquent, the sensational murder case of D'Nagar Police Station has been solved within 12 hours.

On 23.03.2018, a case of 'Murder' was registered at D'Nagar Police Station on the complaint of Shri. Suresh, r/o Thilashpet, Puducherry that his son Saravanan @ Jacky (aged 19 years) was hacked to death near State Bank of India, Gandhi Nagar by a gang, led by one Honestraj, r/o Manthoppu, Veeman Nagar. The investigation of the case was taken up in the right earnest under the leadership of SP(North) Dr. Rachna Singh, who led the team, comprising of Circle Inspector Kannan, Inspector/STF Karthikeyan, SI/STF Ramesh, SI Kalaiarasan and Men of D'Nagar Circle and STF.

The Police team deployed sources in the area and extensively examined the witnesses and locals. The tactful and sincere efforts revealed the real motive for the murder and finally, the Police team located the accused persons, who were on the run across Puducherry and Tamilnadu areas. On 24.03.18, the Police team laid separate traps and the accused persons, viz., 1) **Honest @ Honestraj** (20) S/o Chandramas, No.4, Manthoppe, Veeman Nagar, Puducherry, 2) **Anbu @ Anbarasan** (20) S/o Seenivasan, No.9, Kattapomman Street, Kamaraj Nagar, Gorimedu, Puducherry, 3) **Suriya @ Suriyamoorthy** (20) S/o Kamalanathan @ Natarajan, No.5, Kamban Street, Kamaraj Nagar, Gorimedu, Puducherry, 4) **Deepak @ K.S.Manikandan** (20) S/o Seenivasan, No.12, Periyar Street, Kamaraj Nagar, Gorimedu, Puducherry, 5) **Ram @ Ramkumar** (20) S/o S/o Vengadesan, No.28, Veeraiah Street, Gundupalayam, Puducherry, 6) **Vignesh @ Vicky** (21) S/o Arumugam, No.36, Mariammankoil St,- Gundupalayam, Puducherry, 7) **Ajith @ Ajithkumar** (21) S/o Vengadesan, No.28, Veeraiah Street, Gundupalayam, Puducherry, 8) **Ruban @ Ruba** (20) S/o Anbu, No.12, Servant Quarters, JIPMER, Gorimedu, Puducherry, 9) **Dharma @ Dharmadurai** (19) S/o Purushothaman, No. 17, Vanjinathan Street, Ellaipillaichavadi, Puducherry and one Juvenile Delinquent have been arrested. They have confessed to their crime.

The confession of the accused persons revealed that the deceased Saravanan @ Jacky was having love affair with the sister of the accused Honestraj. Later, due to some misunderstanding, the deceased Saravanan @ Jacky abandoned her, which led her to commit suicide during the month of December 2016. The accused Honestraj challenged to take a revenge against the deceased Saravanan @ Jacky for the suicide of his sister. He conspired with his associates and accomplished his challenge by killing the deceased Saravanan @ Jacky by inflicting grievous injuries on his head, face & chest using long knives.

The confession led to the recovery of the Motor-cycles and blood-stained clothes & weapons.

The deceased Saravanan @ Jacky is a bad character and he is involved in cases of hurt, snatching & Arms Act. Now, he is on bail in a case of Arms Act of D'Nagar Police Station with condition to sign in the Police Station daily.

The accused persons, viz., Honestraj, Ram @ Ramkumar, Ajith @ Ajithkumar, Deepak @ Manikandan, Suriya @ Suriyamoorthy are involved in cases of robbery & hurt.
