Whereas, vide G.O.s cited, a Special court of Judicial Magistrate ("Prison Adalat"), in the Central Prison, Pondicherry has been established for the purpose of holding Prison Adalat in order to consider and dispose of cases of under-trial prisoners and it has further been ordered that the Presiding Officer of the Special Court shall dispose of cases where the accused pleads guilty in respect of offences triable by a Judicial Magistrate of the First Class.

Now, therefore, in exercise of the powers conferred by Section 14(1) Cr.P.C.1973 (Central Act 11 of 1974), I, G. Thanendran, B.Com., M.L., Chief Judicial Magistrate, Pondicherry, hereby order that:

- (i) The Judicial Magistrates I and II of Pondicherry Region shall respectively preside over the Special court of Judicial Magistrate ("Prison Adalat") in the Central Prison, Pondicherry, **on alternate months**, commencing from October, 2013 onwards;
- (ii) They shall hold sittings once or twice in a month or whenever necessary depending upon the work load;
- (iii) They shall exercise all or any of the powers with which they may respectively be invested under the Code of Criminal Procedure; and
- (iv) They shall dispose of cases in respect of offences triable by Judicial Magistrate of the First Class and in which the accused plead guilty.

This order will take immediate effect and remain in force until further orders.
