MEMORANDUM

Sub : Police - Promotion to the post of Inspector of Police
on ad-hoc basis - Orders - Issued.

Thiru. P.K. Sajith, Sub Inspector of Police was not considered for promotion to the post of Inspector of Police during the PEB held on 25.01.2016 and 12.06.2017 along with his juniors as he was facing Departmental Enquiry and he was also declined Vigilance Clearance by the CVO, as there was a case pending against him. As a result the findings of the PEB was kept under sealed cover.

2. Now, on conclusion of DE the Disciplinary Authority has issued a recorded warning vide order 27-1/POL/OSD/DE- 1 / 2015 dt 01.07.2018 treating the period of his suspension as 'Spent on Duty' for all purpose, since the charges levelled against him were held as "not proved". He has also been accorded vigilance clearance Vide Memo. No. C.31016/7/A1/2018/C.V.O dated 26.10.2018.

3. In the PEB held on 20.11.2018 for review, it has been recommended to open the sealed cover and promote Thiru. P.K. Sajith, Sub Inspector Police, to the post of Inspector of Police purely on **ad-hoc** basis, notionally w.e.f., 25.01.2016 on par with his junior Thiru. A. Lakshmanan, with monetary benefit from the date of actual joining in the promotional post of Inspector of Police.

4. Accordingly, P.K. Sajith, Sub Inspector Police (SI Sty. No. 268) is promoted to the post of Inspector of Police purely on **ad-hoc** basis, notionally w.e.f., 25.01.2016 on par with his junior Thiru. A. Lakshmanan, with monetary benefit from the date of actual joining in the promotional post of Inspector of Police. His seniority in the post of Inspector of Police will be fixed in between Thiru. T. Nagarajan, Inspector of Police (SI Sty.No. 264) and Thiru. A. Lakshmanan, Inspector of Police (SI Sty. No. 271).

5. He will draw the Pay LEVEL 7 in the PAY MATRIX (Pre-revised PB-2 :Rs. 9300- 34800 + GP : Rs. 4600) plus usual allowances admissible under rules.

6. If he has already got financial up-gradation under the ACP/MACP scheme, he will not be entitled for any pay fixation on this Promotion.

7. The Posting Order will be issued separately.
