ORDER


03. Police Constable 051139 K. Balamurugan (Seniority No.143) is promoted to the rank of Head Constable in IRBn in the category of Schedule Caste and subject to the outcome of the Criminal case vide No. 179/08 U/s 341, 324, 323, 506 (ii), IPC r/w34 IPC dt. 29.05.2008 registered at Villianur PS, Puducherry pending at Hon'ble Judicial Magistrate - III at Puducherr.

04. As per guidelines of Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training, New Delhi OM No.22011/4/91-Estt-(A) dt.14.09.1992 Para No.5.2 is reproduced below:-

- i. the promotion is being made on purely ad-hoc basis and the ad-hoc promotion will not confer any right for regular promotion and:
- ii. the promotion shall be "until further orders" and Government reserves the right to cancel the ad-hoc promotion and revert at any time the Government servant to the post from which he was promoted.

05. On ad-hoc promotion to Head Constable, India Reserve Battalion, they shall draw their pay and allowances in the pay Matrix : Level-4 and usual allowances as admissible under rule from time to time. Those who have got financial up-gradation under the MACP Scheme will not be entitled to any pay fixation on this promotion.
