Sub : Police - Promotion to the post of Driver (Police Department) Grade – II on ad-hoc basis - Orders - Issued.

Thiru. V. Gobinath, Driver (Police Department) Grade – III was not considered for promotion to the post of Driver (Police Department) Grade – II during the three PEB held on 09.09.2002, 07.01.2004 and 26.11.2010, as he was facing Departmental Enquiry and Criminal Case. As a result the findings of all the three PEB was kept under sealed cover.

2. Now, on conclusion of Departmental Enquiry he is free from all the cases. He has also been accorded vigilance clearance Vide Memo. No. C.31016/7/A1/2018/C.V.O dated 16.10.2018.

3. The PEB held on 05.12.2018 for review, it has been recommended to open the sealed cover and promote Thiru. V. Gobinath, Driver (Police Department) Grade – III, to the post of Driver (Police Department) Grade – II purely on **ad-hoc** basis, notionally w.e.f. 01.02.2004 i.e. on completion of penalty period issued vide Order No. OSD/E1/DE/D7/19-53/SSP(L&O)/2003 dated 22.08.2003 in the first DE case initiated against him vide Memo.No.OSD/E.I/DE/19-53/SSP(L&O)/2002, dt.28.08.2002.

4. Accordingly, Thiru. V. Gobinath, Driver (PD) Grade – III is promoted to the post of Driver (PD) Grade – II purely on ad-hoc basis, notionally w.e.f., 01.02.2004 i.e. on completion of penalty period issued vide Order No. OSD/E1/DE/D7/19-53/SSP(L&O)/2003 dated 22.08.2003 in the first DE case initiated against him vide Memo.No.OSD/E.I/DE/19-53/SSP(L&O)/2002, dt.28.08.2002. His Seniority in the post of Driver (PD) Grade – II will be fixed in between Thiru. J. Sittrarassan and Thiru. A. Balasubramanian.

5. He will draw the Pay LEVEL 4 in the PAY MATRIX (Pre-revised PB-2: Rs.5200-20200 + GP: Rs. 2400) plus usual allowances admissible under rules.

6. If he has already got financial up-gradation under the ACP/MACP scheme, he will not be entitled for any pay fixation on this Promotion.

7. This promotion is Subject to passing of Trade Test required under Recruitment Rules for the post of Driver (Police Department) Grade-II.

8. The above mentioned newly promoted Driver (Police Department) Grade – III is posted in the MT Unit, Police Department, Puducherry.
