MEMORANDUM

Sub : Police - Promotion to the post of Sub Inspector of Police -
Orders - Issued.

Thiru. Seru Nookaraju, Asst. Sub Inspector of Police was not considered for promotion to the post of Sub Inspector of Police during the PEB held on 22.09.2014 and 18.02.2015 as he was facing Departmental Enquiry in a common disciplinary case initiated against him. As a result the findings of the PEB was kept under sealed cover.

2. Now, the Disciplinary Authority has ordered that the charges levelled against him stand closed and filed vide Order No. OSD/DE-1/22-7/DGP/2011, Dt. 10.05.2017. Following the closure of Departmental Enquiry, the Chief Vigilance Office has issued Vigilance Clearance to him.

3. Consequent on the closure of Departmental Enquiry initiated against Thiru. Seru Nookaraju, ASI the sealed cover in which the findings of the PEB was kept, is opened and the Appointing Authority has ordered to promote him notionally with reference to the date of promotion of his next junior.

4. Accordingly, Thiru. Seru Nookaraju, Assistant Sub Inspector Police (ASI Sty. No. 188) is promoted to the post of Sub Inspector of Police on regular basis notionally w.e.f., 19.11.2014 A.N. on par with his junior Thiru. P. Bhaskaran, SI (ASI Seniority No. 139) with monitory benefit from the date of actual joining in the promotional post of Sub Inspector of Police. His seniority would be fixed in the post of SI above Thiru. P. Bhaskaran, SI (ASI Seniority No. 139).

5. He will draw the Pay in LEVEL 6 in the PAY MATRIX (Pre-revised PB-2 : Rs. 9300 - 34800 + GP : Rs. 4200) plus usual allowances admissible under rules.

6. If he has already got financial up-gradation under the ACP/MACP scheme, he will not be entitled for any pay fixation on this Promotion.

7. The Posting Order will be issued separately.
