4. The quotations will be accepted till 16.00 hours on 01.11.2017. The quotations may be sent by registered post /Speed Post/Courier or handed over at the receipt section of the Police Head Quarters, Puducherry. The Police Department, Puducherry is not responsible for the delay in transit, if the quotations are sent by post. The quotations received late i.e. after the date and time prescribed, shall not be accepted. The quotation will be opened at 17.00 hours by the purchase committee on the same day in the office of the SP (HQ) in the presence of bidders or their authorized representatives. In case of unforeseen circumstances the date of opening to be a holiday, the day of opening will be next working day.
5. The materials which do not conform to the specification will not be accepted. Acceptance of the goods is subject to inspection of a committee.
6. The bidders have to quote rate which should include **G.S.T. (Sales Tax or any other charges etc.)** and should cover all incidental charges such as freight, packing, forwarding, insurance, etc.
7. The bidders should furnish the copy of the **GST/TIN Registration Certificates/PAN** and Phone/Mobile phone numbers along with their quotations without fail.
8. The rates to be furnished by the firms should be valid at least for 12 months from the due date and any upward revision of Tax, Cess, etc., would have no impact on that rate(s), while any downward revision should / will duly get effected during the said period.
9. Rates should be quoted **F.O.R. Puducherry** and delivery should be given in the premises of this Department's **Police Radio Branch Stores, (D.Nagar) Gorimedu, Puducherry - 6.**
10. The bidders may quote the rate for the item mentioned as above. Rates should be quoted both in words and figures and every correction should be attested by the person signing the quotation.
11. The bidders must enclose **Demand Draft / FDR for Rs.10,000/- (Rupees Ten thousand only)** from any Nationalized Bank towards the (EMD) Earnest Money Deposit drawn in favour of the Superintendent of Police, Headquarters payable @ Puducherry, Quotation without EMD will not be considered.
12. No interest shall accrue on the above said **EMD** as long as they are held by the Government. The **EMD** in respect of unsuccessful Bidders will be released after finalization of Quotation. The EMD will be refunded to the successful Bidder after satisfactory completion of the supply.

13. The validity of rates should be for **120 days** from the opening of quotations. The rates once quoted and approved will be final until the supplies are received and accepted and no deviation in rates will be allowed thereafter due to market fluctuations or any other reasons.
14. The items have to be supplied within **15 days** on receipt of supply order as door delivery and the charges for the purpose to be borne by the supplier.
15. Warrantee of the above mentioned items should be quoted for **24 months**.
16. The bidders must sign the below mentioned undertaking enclosed herewith.
