In case of recruitment by promotion / deputation / absorption grades from which promotion / deputation / absorption to be made.	<p><u>Promotion:</u> Sub-Inspector of Police in Pay Band-2: Rs. 9300-34800 with Grade Pay Rs. 4200 with 5 years service in the grade rendered after appointment thereto on a regular basis.</p> <p><u>Note 1:</u> Where juniors who have completed their qualifying/ eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.</p> <p><u>Note 2:</u> For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 01.01.2006/the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding Grade Pay/Pay Scale extended based on the recommendations of the Pay Commission.</p>
