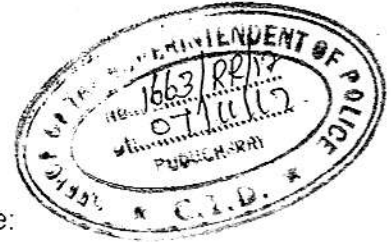

NOTIFICATION

In exercise of the powers conferred by Section 16 of the Puducherry Protection of Interests of Depositors in Financial Establishments Act, 2004 (No.1 of 2005), the Lieutenant-Governor, Puducherry, is hereby appoints Thiru M.S. Maruthupandiyan, Advocate, as the Special Public Prosecutor for the purpose of conducting the cases in the Designated Court constituted under the said Act for the whole of the Union Territory of Puducherry, for a period of three years from the date of assumption of charge.

2. The Special Public Prosecutor shall be paid retainer fee of ₹ 1000/per month and also entitled for payment of, ₹ 5000/- on completion of each case, claim of fees towards preparation of counter, miscellaneous expenses and clerkage charge if any, on each case.

3. The fees to the Special Public Prosecutor shall be paid from the budget of the Revenue Department, Puducherry.
