2. The rates should be quoted for each item as follows:

3. The tenders in sealed cover should be described as "Tender for the purchase of old newspapers and magazines" on annual basis from 01.01.2017 to 31.12.2017 addressed and sent to the "Superintendent of police (HQ), Puducherry 605 001" so as to reach on or before on ~~14~~ 02.2017 at 16.00 hours or should be dropped into the tender box placed at office of Superintendent of Police (HQ) of this Department before the due date mentioned above. The tenders will be opened on ~~14~~ 02.2017 at 17 00 hours in the presence of available tenderers.

4. The intending tenderers should enclose a DD for Rs.1.000/- towards EMD drawn in form the SP(HQ), Puducherry along with the tender. The earnest money deposited by the unsuccessful bidders will be refunded after the tenders are opened and decided and those of the successful bidders will be converted into Security Deposits to be kept in Government account as per procedure.

5. In the event of successful tenderer failing to pay the cost in full and lift the newspapers and magazines at the agreed rate at their own expenses before the close of the fourth day counted from the date of receipt of communication from this office. The Security Deposit will be once and for ever appropriated in favour of the Government and the concerned individual will lose the right of removal of the items for rest of the year also. If the said fourth day happens to be a Government holiday, the deadline will be extended till the next working day on receipt of a specific request in writing from the bidder. No claim about the quantity, quality and value of the sold goods will be admitted.

6. It may be noted that the undersigned reserves the right to reject any or all the tenders without assigning any reason. Contravention of the rules of tender notice will result in the forfeiture of the earnest money deposit/security deposit.


7. The removal of items from the office shall be only during working hours.
